All Modified Racing Series Teams must run **MILTONCAT** Modified Racing Series roof sticker and A-post stickers to be eligible for event purse and point fund monies. Any team without a Modified Racing Series roof and A-post stickers, will have 10% of purse money deducted. A team representative MUST be present at the season ending banquet to receive point money and trophy. Owners may not sell or transfer owner's rights and or car number without prior written consent from the **MRS Tour LLC**.

## **Temporary One Race Membership:**

The fee for a 2023 Modified Racing Series Temporary Membership is \$100.00 (one-hundred dollars). All drivers must hold a valid 2023 Modified Racing Series Membership for competition at any **MRS Tour LLC**. sanctioned event. Only licensed drivers are eligible to attempt to qualify for an event and driver's points.
